# **Objective**

In view of the high number of dilapidated buildings and recent collapses, safety of people and fitness of buildings for human habitation have emerged as crucial concerns. As a result, the need for regular structural assessment is being felt more strongly than ever before. Maharashtra Act No. VI, through its amendments to various municipal corporation acts has made 'Structural Audit' mandatory for all buildings, which are older than 30 years. Municipal corporations have also brought out their guidelines and framed their requirements for Structural Audit.
